Before your participation, it is important for you to understand the risks involved and to acknowledge and accept the responsibilities and liabilities associated with your involvement in the Event.

In consideration of being allowed to participate in the Event, I, the undersigned, hereby agree to the following terms and conditions:

## **Assumption of Risks:**

I am fully aware and understand that participating in a demo derby involves inherent risks, including but not limited to, collisions, vehicle damage, bodily injury, and other potential hazards. I acknowledge that I have been informed of these risks and voluntarily choose to participate in the Event, assuming all such risks willingly and at my own responsibility.

## **Release and Waiver:**

I hereby release, waive, discharge, and covenant not to sue All staff, volunteers, Organizers, sponsors affiliates, its officers, directors, employees, agents, and any other persons or entities involved in the organization or administration of the Event (collectively referred to as "the Released Parties"), from any and all liability, claims, demands, actions, or causes of action arising out of or relating to my participation in the Event, including but not limited to personal injury, property damage, or any other harm, whether caused by the negligence of the Released Parties or otherwise.

## **Indemnification:**

6. Anyone under the influence or in possession of drugs or alcohol will be disqualified and asked to leave. No exceptions
7. Disrespecting an Official will not be tolerated. The Officials have the final ruling.
8. There is to be no driving on the horse track and no aggressive driving in the center field area.
9. Bikes must remain in the pit area when not staging to race
10. Failure to comply with all rules will result in disqualification and will be asked to leave the property.
